## **SPEAKERS**

Patricia Ramsey, President, Ph.D.



Dr. Patricia Ramsey was appointed the sixth president of Medgar Evers College by the City University of New York (CUNY) Board of Trustees. Dr. Ramsey, who officially took office on May 1, 2021, is the first woman and the first scientist to serve in the position of President of the College.

As the thought leader for a \$20 million grant award, just six weeks after Dr. Ramsey arrived, two new programs, Cultivating Holistic Academic Mindsets to Promote Student Success (CHAMPSS) and the Brooklyn Recovery Corps (BRC) programs were created. Both programs provide funding to assist participants in paying for their education.

A biologist by training, Dr. Ramsey has a research interest in the biological activity of plants used in folklore, has collected 110 species of Agave in the Sonoran Desert, and traveled a 450-mile span of highway collecting Sapium sebiferum (popcorn tree) leaves in the southeastern United States. Dr. Ramsey earned a Bachelor of Science in Biology (Education) from Norfolk State University, a Master of Science in Botany from Howard University, a Master of Arts in Biology from Harvard University, and a Doctor of Philosophy in Biology from Georgetown University.

#### Edward Hernandez, Ph.D.



Dr. Edward Hernandez is an Associate Professor at Medgar Evers College and serves as Chair of the Social Work Department. He also teaches online classes in Social Work, Human Services, and Sociology at several universities.

Prior to Medgar Evers College, Dr. Hernandez served as Deputy Commissioner of the Suffolk County Department of Social Services from 2004 until 2012. His career includes over 30 years of government and not for profit agencies positions in largely administrative and management capacities. Dr. Hernandez received his MSW and PhD in Social Welfare from Stony Brook University.

#### Fabienne Snowden, Ph.D.



Dr. Fabienne Snowden is an Assistant Professor with the Social Work Department at Medgar Evers College, CUNY. Dr. Snowden is a graduate of the doctoral program in Social Welfare at the Graduate Center of the City University of New York. Dr. Snowden's research interests include investigating the relationship between contextual factors and individual level experiences, and how it informs effective HIV/AIDS prevention in the U.S and Germany. Dr. Snowden's signature pedagogy focuses on operationalizing intersectionality in social work education.

#### Arlys Tineo, LMSW



Arlys Tineo is a Native Spanish speaker and Licensed Master Social Worker (LMSW) with a background working with diverse populations and a strong advocate for language access and cultural humility. Arlys is currently employed as the Lead Clinician for an Unaccompanied Minor's program at JCCA in Westchester, NY. In her role, she supports and supervises clinicians with service delivery, documentation, and client-related issues in addition to providing direct therapeutic services to Unaccompanied Youth. Before working in child welfare, Arlys worked with various populations and areas such as immigrants, homelessness, college students, medical, psychiatry and victims of natural disaster.

Arlys received a Bachelors of Science in Social Work (BSSW) from Medgar Evers College in 2020 and a Master's in Social Work (MSW) from NYU Silver School of Social Work Advanced Standing Program in 2021. Arlys is currently pursuing a Master's in Public Administration (MPA) with a concentration in Public Policy Analysis at John Jay College and will be completing an Advanced Certificate in Trauma and Disaster Mental Health from SUNY New Paltz in the summer of 2024.

#### **Amaya Carter**



Amaya is a 13 year old female who was born in Brooklyn, NY at Long Island College Hospital. Amaya is currently an 8th grader at Community Roots Charter School.

#### Martha Sullivan, DSW



With a background that includes key positions in government, city and state agencies, and the voluntary sector, Dr. Sullivan has a wealth of experience in healthcare leadership (primary care, acute and long-term care), education, policy, planning and program development. She is dedicated to developing and increasing access to culturally competent, quality health and behavioral health services for underserved and minority populations, including older adults, women, people of color and people who are seriously mentally ill or homeless.

As Executive Director of Creedmoor Psychiatric Center, Dr. Sullivan oversees the largest state operated psychiatric

center in New York City and the second largest in New York State which includes inpatient, residential and an array of outpatient services.

Previously, as Health + Hospitals/ Gouverneur's Executive Director, Dr. Sullivan lead the largest Diagnostic and Treatment Center in New York and a large Skilled Nursing Facility. It was there that Dr. Sullivan previously developed the innovative and pioneering Center for Older Adults and Their Families and the Women's Comprehensive Mental Health Program at Gouverneur, where she later served as Director of Behavioral Health. She is the only social worker to have held such a position in H+H.

Dr. Sullivan has served as Deputy Commissioner of NYC DOHMH, overseeing chemical dependency, mental health promotion and community liaison. As **Executive Director of the** Fordham-Tremont **Community Mental** Health Center (St. Barnabas Hospital), she developed specialty services, including the Men's Mental Health Service, and produced the documentary film Men of Color and Mental Health: Moving from Alienation to Hope.

Dr. Sullivan holds a master's degree from the Silberman School of Social Work of Hunter College at CUNY where she also has served as an adjunct professor. She earned a **Doctor of Social Welfare** degree from the CUNY Graduate School. She also holds a Master of Theology degree from St. Joseph's Seminary, Dunwoody, NY. Some community and professional activities include: former trustee, St. Charles Borromeo Church, where she developed the Lazarus Project, a ministry of consolation serving parish and community and where she leads the Anti-Violence Project for the Social Justice Committee. Dr. Sullivan is a Fellow of the New York Academy of Medicine where she also serves as vice chair of the Healthy Aging section. Dr. Sullivan chairs the Advisory Board of the Lt. Joseph P. Kennedy Center in Harlem. She is founder and CEO of the Citywide Behavioral **Health Coalition for Black** Elders, Inc.

As a past president of the NYC Chapter of NASW, Dr. Sullivan spearheaded the Social Work Equity Project including the published report: Worse Than You Think. The Dimensions of Poverty in NYC: What Social Workers See.

#### Eva M. Gordon, LCSW



Eva M. Gordon, LCSW, has been a social worker in the New York City area for over 19 years. Ms. Gordon is currently the Director of Life Guide, LCSW. P.C., providing mental health services in the New York City area. The goal is to promote healing from past and current pain through psychotherapy for individuals and groups. Many clients are treated for depression, anxiety, bereavement, family, and marital issues. Prior to this, she was a psychotherapist at the Center For Psychotherapy in Brooklyn, NY. The Center provides mental health services to the Black community within a cultural framework. She previously served as the Program Coordinator for the Community Partnership Program (CPP) of East New York,

a referral network of 40+ organizations strengthen children and families with services in the East New York area. The CPP's work focused on providing and training community workers for child welfare conferences, foster parent recruitment and support, workshops, health fairs and training events.

A native of Brooklyn, NY, Ms. Gordon is a graduate of the New York City public school system. After high school, Ms. Gordon continued her studies at the University of Pittsburgh, where she received her BA in Sociology in 2000. Ms. Gordon's work with families began in 2001 at Seamen's Society for Children and Families Brownsville **Preventive Services** Program, which also provided respite services. Ms. Gordon continued her work as a substance abuse prevention and intervention specialist in the SPARK program at John Adams High School, Ms. Gordon then completed her Masters in Social Work from Columbia University School of Social Work in 2007.

She was also the coordinator for the Young Adult Supportive Services program at **Harlem Congregations** for Community Improvement (HCCI). The program provided supportive housing services for youth aging out of foster care. In addition to her professional experience, Ms. Gordon volunteers as Chairperson of Your Body Is a Temple (YBIT) Health Ministry at Siloam Presbyterian Church in Brooklyn, NY. The health ministry provides information on health topics, especially providing HIV outreach events, health fairs, and workshops. In her spare time, Ms. Gordon spends time with her family and friends in Brooklyn, NY. She enjoys live music events and movies, as well as creative writing.

#### Shirley de Peña, Ph.D.



Dr. Shirley de Peña is a dedicated professional committed to fostering success and well-being, particularly among foster youth in the academic setting. Currently serving as the Director of the Foster Youth College Success Initiative (FYCSI) at the City University of New York (CUNY), she brings over 20 years of invaluable experience to her role.

In her capacity as the Director of FYCSI, Dr. de Peña spearheads a program designed to empower foster youth at CUNY, ensuring they not only navigate the challenges of college life but thrive academically. Her approach involves personalized support, both individually and in small group settings, with the goal of enhancing retention and graduation rates.

Prior to joining CUNY, Dr. de Peña's professional journey included a significant tenure at the Jewish Board. Over the course of 15 years, she transitioned from a social worker to an administrative supervisor in the **Preventive Services** Division, ultimately serving as the Internship Coordinator and Master Trainer in the Martha K. Selig Educational Institute. Her passion for holistic student development was evident as she managed JBFCS' Bicultural Institute, providing educational support for social work interns of color.

Dr. de Peña's commitment extended beyond her roles, as she actively participated in voluntary professional service within the Jewish Board and the broader community. She emerged as one of the Jewish Board's prominent leaders in advancing Anti-Racist Policy and Practice, providing consultation and training to the NYC Administration for Children Services (ACS) and other major social service agencies on matters of race and the Latino experience.

As an organizational consultant, Dr. de Peña imparts her expertise in areas such as social work licensure preparation, understanding the impact of race and culture on clinical and case work practice, and fostering positive race relations in the workplace. Her influence extends to academia, where she holds teaching posts as an adjunct professor at NYU Silver School of Social Work and Silberman School of Social Work at Hunter College. Dr. de Peña earned her social work degree at Stony Brook University and furthered her academic journey with a **Doctoral Degree in Social** Welfare at Yeshiva University. Her multifaceted experience, coupled with a genuine dedication to social welfare and education, underscores Dr. Shirley

#### Durrell Washington, Ph.D. candidate



A Native New Yorker from the Bronx Durrell Malik Washington Sr. is an **Abolitionist Social Worker** and PhD Candidate at the University of Chicago School of Social Work, Policy, and Practice. Durrell is an interdisciplinary scholar whose research draws from social work, sociological, criminological, developmental, and legal theories and perspectives. His research interest lies at the intersections between P.I.C. Abolition, Juvenile legal law and policy, Black families, and Health. Durrell is a former mental health clinician and policy analyst with years of experience supporting formerly incarcerated young people, adults and their families.

His current dissertation is a Narrative study that investigates how a period of juvenile incarceration shapes Black family life in the United States through the perspective of siblings of formerly incarcerated Black boys and girls. Durrell is a 2022 American Society of Criminology Ruth D Peterson Fellowship Award Recipient, Received his MSW from Columbia University in 2018 and BSW from CUNY York College in 2017.

#### Latoya Delmadge, LCSW-R



Latoya A. Delmadge is a Licensed Clinical Social Worker, who functions as the Director of the Social Work Behavioral Health Department at Kings County Hospital Center, leading over 80 staff in providing patientcentered care. Before her career at Kings County, Mrs. Delmadge developed and oversaw an Article 31 and 822-satellite communitybased clinic in Brooklyn, treating children and adults with serious mental illness and co-morbid conditions. With more than fifteen years of clinical mental health experience, Latoya is well-versed in various evidence-based practices and trauma-informed care.

Latoya specializes in mindful-based trauma treatment and has obtained extensive training from Harvard University on traumabased treatment and mindfulness practices. Mrs. Delmadge is a proud graduate of Touro University, where she received her master's degree in social work, and is currently a Doctoral candidate at Liberty University, in Lynchburg, Virginia. Mrs. Delmadge has spent her career, addressing gaps in treatment for vulnerable populations and providing education on mental health needs and services, through various speaking engagements throughout New York City. As a member of the SW Director's Council for New York City Health and Hospital, Latoya is a devout advocate for the social work profession, social justice, health equity, and behavioral health.

#### Manny De Los Santos, NYS Assemblymember



Manny De Los Santos is a dedicated public servant who has devoted his life to advocating and fighting for New Yorkers. For the last 10 years, she has remained a civil servant committed to helping build a New York City that is safer, more just, and more equitable for children and families, working for the Administration for Children's Services (ACS). Gloria began her career at ACS as a Child **Protective Specialist for** the Protective Diagnostic Unit but quickly moved on to the ACS Child Advocacy Center as part of the Instant Response Work Group. Gloria spent the last 5 ½ years as a Child and Family Specialist, remaining committed to strengthening and stabilizing families in crisis by facilitating emergency conferences for the boroughs of Staten Island, Manhattan, and the Office of Special Investigation. While there, she participated in the Family Team Conference Advisory Board.

She currently assumes the role as the Clinical Manager of Social Work at the Nicholas Scoppetta Children's Center. Her newer responsibilities include providing enduring solutions that lead to timely permanency, safe

stable placements, and quality trauma-informed care for children with complex needs.

Throughout her career, Gloria has provided compassionate and evidence-based interventions to individuals, families, and groups. She became adept at addressing diverse mental health challenges and fostering resilience in clients. This allowed her to also pursue a more therapeutic approach grounded in evidence-based practices and integrating psychodynamic principles. As a Psychotherapist for NYC's seasoned citizens, Gloria maintains a safe and empathetic space where her clients can explore their unique narratives, unravel challenges, and cultivate resilience. Dr. Richardson completed her Master's degree in Clinical Social Work at Fordham University and Bachelor's degree in Liberal Arts with a concentration in Human Services at City College (CUNY).

Dr. Richardson has more than 20 years of experience working with individuals and families involved in the child welfare, juvenile justice, mental health, criminal justice, and homeless services fields. She began her career working with children and families in the foster care system in New York.

She went on to work in a specialized behavioral health foster care program, a residential program, and an in-home individual/family therapy program.

Dr. Richardson was also served in several administrative positions, including Director of Quality of Assurance, and Vice President of Foster Care Services. In 2016, she was hired at the College of Staten Island (CUNY) as an adjunct lecturer and field education ligison in the Master of Social Work program. She joined Medgar Evers College in 2019 as a substitute lecturer and was then promoted to Assistant Professor in 2021. Dr. Richardson was also the Field Education Coordinator and assisted the Field Education Director with field placements and other administrative responsibilities. In 2022, she began in private practice providing individual, couples, and family therapy and clinical consultation. She is a mental health normalizer that specializes in trauma, formerly incarcerated or individuals facing incarceration, family of origin and relationship issues,

stress management, anxiety, depression, grief and loss, and personal growth utilizing an eclectic variety of treatment approaches.

Dr. Richardson serves on several college committees including: the Academic Standards and Regulations, Social Work Conference Planning and Technology committees. She has redesigned several social work courses to be more inclusive of Open Education Resources (OER) thereby reducing overall textbook costs for students. She enjoys teaching a variety of social work courses and hopes that students leave her class feeling heard and valued. Dr. Richardson also strives to ensure students learn first and foremost to gain the competencies and skill sets they will need to be successful in their chosen field of social work practice and become social justice warriors.

#### Kevin Haynes, Legal Coordinator



Kevin Haynes is a paralegal and staunch advocate for prison and sentencing reform. He currently works at North Star Youth Initiative as a Legal Coordinator, working closely with the CEO, community stakeholders, and young people to reduce violence and provide assistance navigating the criminal justice system.

Mr. Haynes' advocacy work includes collaborating with The Holloway Project, led by former federal judge and current partner at Debevoise and Plimpton, LLC, John Gleeson. The Holloway Project advocates on behalf of prisoners, largely men of color, against unjust, mandatory stacked prison sentences, pro bono.

The project has shaved more than 1,100 years in prison time for more than 34 prisoners. Mr. Haynes has done presentations on prison and sentencing reform at Yale, Harvard, and New York Universities as well as the New York State Bar Association.

In addition, Mr. Haynes worked with the founders of Mercy Me to create legislation that would reform mandatory minimum sentences. He also collaborated with representatives from Destine Advocacy Project (DAPA) to write senators, congressional leaders, and judges to advocate for social change within the criminal justice and penal systems. Furthermore, Mr. Haynes has drafted motions and briefs and served as legal advisor on behalf of 30 people nationwide. Mr. Haynes also serves as a panelist on a number of podcasts that informs listeners

of injustices
happening across the
country and educates
them on steps, they
can take to become
advocates for social

volunteer at John
Wesley Methodist
Church Food Pantry
with pastor Sheila
Beckford.

Mr. Haynes has dedicated his life to helping and serving others in any capacity he can but has a true passion for reforming laws that disproportionately effect individuals and communities of color.

#### Divine Pryor, Ph.D.



Dr. Divine Pryor is currently the Co-Founder, CEO & amp; President of the People's Police Academy. The People's Police Academy (PPA) is a non-profit, community based and lead, training, education, research and direct service organization that is now being incubated in the **Dubois-Bunche Center** for Public Policy at Medgar Evers College (MEC) in the City University of New York. The Academy will draw on and combine institutional and community-based resources and expertise to offer specialized training and direct services to all community stakeholders throughout NYC's five boroughs and beyond. The training cohorts will be comprised of law enforcement,

local community and faith leaders, public health and safety personnel, city probation and corrections officers, youth and young adults, public school safety and school crossing quards, faith and civic leaders, long-term community residents, college faculty and researchers, students, local merchants and service providers in both the public and private sectors. Its staff was comprised of academic professionals with prior experience within the criminal punishment system. It is the first and only public policy center of its kind in the country. having spent over half his career administering HIV/AIDS, domestic violence. substance abuse and other social service non-profits. Dr. Pryor also provides on-going TA to **Community Capacity** Development, Osborne, Fortune and other nonprofits who are working in the area(s) of criminal justice and public safety.

#### Zoe Naomii Clarke, BSSW Student




