I. Call to Order

Self-Study Announcement:

- President Ramsey announced that the Self-Study process has officially begun and must be completed by next year.

Self-Study Update – Dr. Shirley Daniels:

- o The Middle States Commission has approved the College's Self-Study plan.
- The plan includes a guide outlining each standard.
- Brightspace will be used for document storage, communication, and dissemination across working groups.
- o The Steering Committee will meet on Thursday, September 26 at 2:00 PM.

Strategic Plan:

Governance Plan:

 The CUNY Board of Trustees approved the Governance Plan amendments in June, and the changes will be implemented accordingly.

'Going for Gold' Certification:

- The College earned a 'Going for Gold' certification focused on cancer awareness, led by committee co-chairs, SVP Kane and Ms. Hanes (HR)
- The kickoff ceremony will be held in the Edison Jackson Auditorium on October 8 and 9.

VI. Standing Committee Reports

A. Committee on Governance (E. Catapane, chair)

The committee's work will focus on reviewing, editing, and amending the governance plan. This process will be ongoing and will require at least one College Council meeting for reading amendments only.

- B. Committee on Administrative Advisory no report
- C. Committee on Student Life (J. Kane, chair)
 - CUNY Student Affairs is preparing for emotional or activist responses from students regarding the anniversary of the attack on Israel and the presidential election.
 - Student Success has received \$250K+ in support grants to assist students in dire financial need.
 - Academic record reviews are underway to correct credit/grade errors and resolve issues with phantom students.
- D. Committee on College-wide Curriculum (S. Fischer, chair) -

- The Curriculum Committee has met once and will forward reviewed proposals from Nursing, Social Science, and English.
- Provost Coleman reported that the School of Education submitted a master's degree proposal last spring and is currently working on revisions.
- This would be MEC's first graduate-level program, requiring approval from CUNY and the New York State Education Department (NYSED).
- The Chemistry Department has also proposed a master's degree program in cannabis.

VII. Announcements

- President Ramsey attended the White House Initiative National HBCU Week, where she met actress Malinda Williams (<u>Arise and Shine Inc.</u> E.S.T.E.A.M project), which supports girls in STEM at HBCUs and has committed to including MEC.
- Peter Holoman announced that MEC is now on the recruitment list for a national internship program that directly recruits from HBCUs. One MEC student has already secured a placement.
- On Oct. 15, CUNY Chancellor Rodriguez and a JP Morgan Chase representative will visit campus to announce a partnership with MEC.
- Dr. Castro reported that MEC is now a hub for students across CUNY and other institutions seeking partnership opportunities; the Nursing program's outreach continues to strengthen connections between MEC and the broader community.
