**Application for Federal Direct Parent Loan for Undergraduate Students (FPLUS) 2025-2026**

Under the Federal Direct Loan Program, your lender is the United States Government. You **MUST** complete a PLUS Master Promissory Note (MPN) before your loan can be disbursed. You must complete an electronic Master Promissory Note, using your FSA user id and password, at <https://studentaid.gov/mpn/>.

If you qualify for a Direct Loan, the excess funds will be disbursed to you in a check mailed to the address you provide on the application, or to your child if you so designate below. The Interest rate on the FPLUS loan for 2025-2026 is fixed at 8.94% (for the life of the loan). There is an origination fee of 4.228% that will be deducted automatically.
